The stake becomes 3.47% taking into account shares lent as collateral by JMSAN Agentes Financieros Globales, S.L. to GLOBAL CORPORATE FINANCE OPPORTUNITIES 15 and the 1,500,000 shares lent as collateral by Mr. Lorenzo Serratosa Gallardo to GLOBAL CORPORATE FINANCE OPPORTUNITIES 15 as heard on 23/12/2022.
- (c) Member of the Board of Directors of the Company, who in addition to his direct participation maintains an indirect stake in the Company through JMSAN Agentes Financieros Globales, S.L. The stake becomes 4.65% taking into account the shares lent by JMSAN Agentes Financieros Globales, S.L. to GLOBAL CORPORATE FINANCE OPPORTUNITIES 15.

The remaining shares (19,125,000) were divided equally among the former shareholders of JMSAN Agentes Financieros, S.L. (D. Fernando Villar del Prado and D. Fco. Javier Muñoz Sanfeliu). It should also be noted that 13,088,254 shares of which JMSAN Agentes Financieros, S.L. is the owner, are managed by a broker as the owner of the shares.
- (b) All the shares of Mr. Francesc Xavier Ramos and part of the shares of Mr. Fco. Javier Muñoz Sanfeliu have been deposited in "participation accounts" of Indico Investments and Management, S.L.
- (c) The broker that manages the investments (shares) owned by Yaro Investment Holding, Ltd. and United General, Ltd. is listed as the owner of the investments.

These percentages have been calculated on the basis of the 100,611,739 class A shares and the 138,638,460 class B shares into which the company's share capital is currently divided.

The Board of Directors is not aware of the existence of other shareholders with a position of more than 5%.
