Pursuant to the provisions of Article 17 of Regulation (EU) No 596/2014 on market abuse and Article 227 of Law 6/2023 of 17 March 2023 on Securities Markets and Investment Services, and related provisions, as well as Circular 3/2020 of BME Growth of BME MTF Equity, we hereby inform you of the following information regarding SUBSTRATE ARTIFICIAL INTELLIGENCE, S.A. (hereinafter ("Substrate AI" or "the Company" indistinctly).

OTHER RELEVANT INFORMATION

On May 14, 2025, the Company published as Other Relevant Information ("OIR") the resolutions adopted by the Extraordinary General Shareholders' Meeting held on May 14, 2025, among which was the delegation to the Board of Directors of the power to issue debentures convertible into shares of the Company itself for a maximum nominal amount of €17,200,000, as well as to increase the share capital in the amount necessary to meet the conversion of said Bonds.

Likewise, at its meeting held on July 22, 2025, the Board of Directors adopted the resolution, under the delegation of the Meeting, to carry out a second issue of 100 Bonds convertible into shares of the Company for a joint nominal conversion amount of 1,000,000 euros, the "JULY 2025 Convertible Debentures", as well as the issuance of 1,632,653 convertible warrants "T2 ATM WARRANTS" ATLAS CAPITAL MARKETS being the sole recipient of these issues.

The terms and conditions of conversion of these Bonds and Warrants were set out in the IP dated June 12, 2025.
